Minnesota Statutes 2022, section 171.13, is amended by adding a subdivision 1.7 to read: 1.8 Subd. 10. Written examination plain language requirements. (a) For purposes of this 1.9 subdivision, the following terms have the meanings given: 1.10 (1) "committee" means the Department of Public Safety, Division of Driver and Vehicle 1.11 Services Test Maintenance Committee responsible for monitoring, reviewing, and editing 1.12 the written portion of the driver's knowledge examination on behalf of the Division of Driver 1.13 and Vehicle Services; 1.14 (2) "plain language standards" means the requirements specified in paragraph (b) and 1.15 the requirements of the Plain Writing Act, Public Law 111-274, and Executive Order 14-07; 1.16 1.17 and (3) "written examination" means the written portion of the driver's knowledge examination 1 18 in English and administered under this section. 1.19 (b) By February 1, 2025, the commissioner must implement plain language standards 1.20 and create a new written portion of the knowledge examination to ensure the written 1.21

2.7	(5) utilize commonly used and familiar words;
2.8	(6) avoid turning verbs into nouns through nominalization;
