2.20 (b) The revisor of statutes shall make necessary cross-reference changes in Minnesota  
 2.21 Statutes and Minnesota Rules consistent with renumbering of Minnesota Statutes, chapter  
 2.22 136D in this act, and if Minnesota Statutes, chapter 136D, is further amended in the 2018  
 2.23 legislative session, shall codify the amendments in a manner consistent with this act. The  
 2.24 revisor may make necessary changes to sentence structure to preserve the meaning of the  
 2.25 text.

2.26 **EFFECTIVE DATE.** This section is effective the day following final enactment.
