1.9	certified aid for the previous year is less than its current unmet need, the city shall receive
1.10	an aid distribution equal to the sum of (1) its certified aid in the previous year, and (2) the
1.11	city formula aid under subdivision 8.
1.12	(b) For aids payable in 2024 and thereafter, if a city's certified aid for the previous year
1.13	is equal to or greater than its current unmet need, the total aid for a city is equal to the greater
