1.9	pledge that is made contingent on an appropriation is acceptable and shall must be reported
1.10	with other pledges as required in this section. The commissioner may agree to match a

Sec. 3. Minnesota Statutes 2022, section 84.943, is amended by adding a subdivision to read:

Subd. 7. Report. By January 15, 2026, and every two years thereafter, the commissioner must report on the expenditure of money during the previous biennium from the critical habitat private sector matching account and the nongame wildlife management account.

The commissioner must submit the report to the chairs and ranking minority members of the legislative committees and divisions with jurisdiction over environment and natural resources.
