BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
Section 1. COMMISSION TO STUDY REPARATION PROPOSALS FOR AFRICAN
AMERICAN AND AMERICAN INDIAN MINNESOTANS.
Subdivision 1. Legislative findings. (a) The legislature finds acts of injustice, cruelty,
brutality, and inhumanity have been suffered by African American Minnesotans in the
course of the state's history.
(b) The legislature finds acts of injustice, cruelty, brutality, inhumanity, and genocide
have been suffered by American Indian Minnesotans in the course of the state's history.
Subd. 2. Establishment of commission; purpose and duties. A commission to identify
historical findings and to study reparation proposals for African American and American
Indian Minnesotans is established.
Subd. 3. Membership; meetings. (a) The commission consists of 22 members. The
governor is the appointing authority and shall consult with the Council for Minnesotans of
African Heritage and the Indian Affairs Council in making appointments. In making
appointments under this subdivision, the appointing authority must consider an individual's
experience related to the commission's purpose and duties. Relevant experience may include,
but is not limited to, an individual's academic training, life experiences, and history of public

Appointments must be made 2.1 no later than July 1, 2020. 2.2 (b) The commission shall elect a chair and vice-chair and other officers as determined 2.3 by the commission. The first meeting shall be convened by the governor no later than 2.5 August 1, 2020. 2.6 (c) Commission members shall serve until the commission's work is complete. Vacancies 2.7 must be filled by the appointing authority for the vacant position. Report on recommendations; expiration. The commission shall submit a 2.15 report on its findings and recommendations to the governor and to the legislature no later 2.16 than January 15, 2022.
