BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

A bill for an act

Section 1. [626.893] BRADY-GIGLIO.

Subdivision 1. **Definition.** "Brady-Giglio designation" means a designation made or list 1.6 compiled by a prosecuting agency containing the names and details of peace officers who 1.7 have sustained incidents of untruthfulness, criminal convictions, candor issues, or other 1.8 1.9 issue that places the officer's credibility into question.

Subd. 2. Confidential employment data. The employing state or local law enforcement agency shall keep a peace officer's statement, recordings, or transcripts of any interviews or disciplinary proceedings, and any complaints made against a peace officer confidential unless otherwise provided by law or with the officer's written consent. Nothing in this section prohibits the release of an officer's statement, recordings, or transcripts of any interviews or disciplinary proceedings and any complaints made against an officer to the officer or the officer's legal counsel upon the officer's request.

Subd. 3. Employee data request. Upon written request, the employing state or local law enforcement agency shall provide to the requesting peace officer or the officer's legal counsel a copy of the officer's personnel file and training records regardless of whether the officer is subject to a formal administrative investigation at the time of the request.

Subd. 4. Officer discharge. (a) A peace officer shall not be discharged, disciplined, or 1.21 threatened with discharge or discipline by a state or local law enforcement agency solely 1.22

Release of information. A prosecuting agency shall keep confidential and shall 4.20 not release to the public an officer's personnel file, medical records, or any statement, 4.21 recording, transcript, or complaint unless otherwise provided by law or with the officer's 4.22 written consent. Nothing in this subdivision shall be construed to prohibit the release of 4.23 records to the officer or the officer's legal counsel as required under this section upon the 4.24 request of the officer or the officer's legal counsel or as otherwise provided by law or court 4.25 4.26 order. **EFFECTIVE DATE.** This section is effective the day following final enactment. 4.27
