1.9	Notwithstanding anything in this chapter, the owner of a brew on premises store shall
1.10	not be considered a brewer, manufacturer, wholesaler, or retailer of intoxicating liquor if
1.11	the owner complies with this section and with Code of Federal Regulations, title 27, part
1.12	25, subpart L, sections 25.205 and 25.206. For purposes of this section, a brew on premises
