1.5	Section 1. DISTRIBUTION PROHIBITED UNTIL CONDITION SATISFIED.
1.6	(a) The Maplewood Firefighters Relief Association shall not make a distribution of
1.7	benefits to any member or pay any expenses, except usual and customary administrative
1.8	expenses, until the relief association either:
1.9	(1) obtains the consent of the governing body of the city of Maplewood to any amendment
