1.5	Section 1. ST. PAUL; EAST 7TH STREET PARK DEVELOPMENT.
1.6	Subdivision 1. Appropriation. \$5,876,000 is appropriated from the bond proceeds fund
1.7	to the commissioner of employment and economic development for a grant to the city of
1.8	St. Paul to acquire property, for environmental remediation, and to predesign, design,
1.9	construct, furnish, and equip a new public city park on the former Cemstone site along East
1.10	7th Street in the city of St. Paul, subject to Minnesota Statutes, section 16A.695.
1.11	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
1.12	proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.13	the state in an amount up to \$5,876,000 in the manner, upon the terms, and with the effect
1.14	prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
