1.5	Section 1. CHILD CARE REGULATION WORKING GROUP.
1.6	Subdivision 1. Establishment; members. The commissioner of human services or the
1.7	commissioner's designee shall convene a child care regulation working group that consists
1.8	of no more than 30 members, including, but not limited to:
1.9	(1) two licensed family or group family day care providers;
1.10	(2) two licensed child care center providers;
1.11	(3) two directors or owners of child care centers;
1.12	(4) one retired family or group family day care provider, or a provider that voluntarily
1.13	closed their program within the last three years;
1.14	(5) the commissioner of human services or the commissioner's designee;
1.15	(6) two county employees who perform child care licensing duties in the metropolitan
1.16	area as defined in Minnesota Statutes, section 473.121, subdivision 2;
1.17	(7) two county employees who perform child care licensing duties outside of the
1.18	metropolitan area as defined in Minnesota Statutes, section 473.121, subdivision 2;
1.19	(8) two representatives from the Minnesota Child Care Association;
1.20	(9) one representative from the Minnesota Association of Child Care Professionals;
