(a) By July 1, 2024, the commissioner of human services, in consultation with staff from the Office of the Revisor of Statutes; House Research Department; House Fiscal Analysis; and Senate Counsel, Research and Fiscal Analysis, shall prepare legislation for introduction in the 2025 legislative session proposing the statutory changes needed to permit reimbursement of personal care assistants and community-first services and supports workers to provide up to eight hours of overtime per week per worker beyond the maximum number of reimbursable hours per month.

(b) By January 1, 2025, the commissioner of human services shall submit to the federal Centers for Medicare and Medicaid Services any necessary changes to applicable waivers or amendments to the state plan to permit reimbursement of personal care assistants and community-first services and supports workers to provide up to eight hours of overtime per week per worker beyond the maximum number of reimbursable hours per month.
