BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

## Section 1. APPROPRIATION; ONLINE EARLY CHILDHOOD DEVELOPMENT PROFESSIONAL EDUCATION PROGRAM.

(a) \$1,500,000 in fiscal year 2025 is appropriated from the workforce development fund to the commissioner of human services for the purchase and operation of an online early childhood development professional educator program. The commissioner must select an online provider to provide a professional development program at no cost to early childhood educators. The program selected must include all of the coursework in English or Spanish necessary to earn a Child Development Associate Certificate upon successful completion, must provide courses allowing for the award of Continuing Education Units accredited by the International Accreditors for Continuing Education and Training, must provide health and safety courses meeting federal annual training requirements under the child care development block grant and the child care and development fund, and must be usable for students in high school career and technical education programs. Membership in the program must be distributed on a first-come, first-served basis to Minnesota educators currently working in, or Minnesota residents interested in working in, licensed early education facilities, including prekindergarten programs, child care, Head Start Centers, resource and referral agencies, and family child care homes.
