1.5	Section 1. PRIVATE SALE OF TAX-FORFEITED LAND BORDERING PUBLIC
1.6	WATER; CARLTON COUNTY.
1.7	(a) Notwithstanding Minnesota Statutes, sections 92.45 and 282.018, subdivision 1,
1.8	and the public sale provisions of Minnesota Statutes, chapter 282, Carlton County may sell
1.9	by private sale the tax-forfeited land bordering public water that is described in paragraph
1.10	(c), under the remaining provisions of Minnesota Statutes, chapter 282.
