- (h) A charter school must develop and implement a teacher evaluation and peer review process under section 122A.40, subdivision 8, paragraph (b), clauses (2) to (13), and place students in classrooms in accordance with section 122A.40, subdivision 8, paragraph (d). The teacher evaluation process in this paragraph does not create any additional employment 2.10 rights for teachers. 2.11
  - (i) A charter school must adopt a policy, plan, budget, and process, consistent with section 120B.11, to review curriculum, instruction, and student achievement and strive for the world's best workforce.
  - (j) A charter school is subject to and must comply with the Pupil Fair Dismissal Act, sections 121A.40 to 121A.56.
- (k) A charter school must comply with the prohibition on American Indian mascots 2.17 under section 123B.493. A charter school may seek an exemption under section 123B.493, 2.18 paragraph (b). 2.19

## Sec. 3. [135A.154] AMERICAN INDIAN MASCOTS PROHIBITED.

- (a) A public postsecondary institution may not have or adopt a name, symbol, or image 2.21 that depicts or refers to an American Indian Tribe, individual, custom, or tradition to be 2.22 used as a mascot, nickname, logo, letterhead, or team name of the institution. 2.23
- (b) A public postsecondary institution may seek an exemption to paragraph (a) by 2.24 submitting a request in writing to the Tribal Nations Education Committee and the Indian 2.25 Affairs Council, which jointly shall have discretion to grant such an exemption. 2.26
