1.9	Subdivision 1. Membership. The Advisory Committee for Technology Standards
1.10	for Accessibility and Usability consists of ten members, appointed as follows:
1.11	(1) the state chief information officer, or the state chief information officer's designee;
1.12	(2) a representative from State Services for the Blind, appointed by the commissioner
1.13	of employment and economic development;
1.14	(3) the commissioner of administration, or the commissioner's designee;
1.15	(4) a representative selected by the Minnesota system of technology to achieve
1.16	results program;
1.17	(5) a representative selected by the Commission of Deaf, DeafBlind, and Hard
1.18	of Hearing Minnesotans;
1.19	(6) the commissioner of education, or the commissioner's designee;
1.20	(7) the commissioner of health, or the commissioner's designee;

2.1	The appointing authorities under this subdivision must use their best efforts to ensure
