(a) The purpose of the essential 1.6 community supports program is to provide targeted services to persons age 65 and older 1.7 who need essential community support, but whose needs do not meet the level of care 1.8 required for nursing facility placement under section 144.0724, subdivision 11. 1.9 (b) Essential community supports are available not to exceed \$400 \$600 per person per 1.10 month. Essential community supports may be used as authorized within an authorization 1.11 period not to exceed 12 months.
