1.6	Section 1. APPROPRIATION; MINNESOTA COUNCIL ON DISABILITY.
1.7	Subdivision 1. Appropriation. (a) \$250,000 in fiscal year 2024 and \$250,000 in fiscal
1.8	year 2025 are appropriated from the general fund to the Minnesota Council on Disability
1.9	to select, appoint, and compensate employees to perform the following tasks:
1.10	(1) in consultation with the League of Minnesota Cities, the Association of Minnesota
1.11	Counties, and the Minnesota Association of Townships provide a statewide training module
1.12	for cities, townships, and counties on how to conform local government websites to
1.13	accessibility standards;
1.14	(2) provide outreach, training, and technical assistance for local government officials
1.15	and staff on website accessibility; and
1.16	(3) track and compile information about the outcomes of the activities described in
1.17	clauses (1) and (2) and the costs of implementation for cities, townships, and counties to
1.18	make website accessibility improvements.
1.19	(b) The training module described under paragraph (a), clause (1), must be developed
1.20	and made available to counties, townships, and cities on or before July 1, 2024.
1.21	(c) This appropriation is onetime. The base for this appropriation in fiscal year 2026 and

2.1	Subd. 2. Report to the legislature. On or before January 15, 2025, and annually on
2.2	January 15 thereafter, the Minnesota Council on Disability shall submit a report to the chair
2.3	and ranking minority members of the legislative committees with jurisdiction over state
2.4	government finance and local government specifying the number of cities, townships, and
2.5	counties that received training or technical assistance on website accessibility, the outcomes
2.6	of website accessibility training and outreach, the costs incurred by cities, townships, and
2.7	counties to make website accessibility improvements, and any other information that the
2.8	council deems relevant.
