**EFFECTIVE DATE.** This section is effective beginning with taxes payable in 2018.

- Sec. 2. Minnesota Statutes 2016, section 276A.06, subdivision 5, is amended to read:
- Subd. 5. **Areawide tax rate.** (a) On or before August 25<del>, 1997, and of each subsequent</del> year, the county auditor shall certify to the administrative auditor the preliminary portion of the levy of each governmental unit determined pursuant to subdivision 3, clause (1). The administrative auditor shall then determine the areawide tax rate sufficient to yield an amount equal to the sum of the levies from the preliminary areawide net tax capacity.
- (b) The areawide tax rate may not deviate from the previous year's areawide rate by more than three percentage points. If the areawide tax rate determined under paragraph (a) does not fall within that range, the auditor must determine the percentage increase or reduction to each jurisdiction's distribution levy necessary so that the areawide rate falls within the range and recalculate the areawide rate accordingly.
- 2.16 (c) On or before September 1, the administrative auditor shall certify the areawide tax rate to each of the county auditors.
- 2.18 **EFFECTIVE DATE.** This section is effective beginning with taxes payable in 2018.
