A bill for an act

1.1 relating to public safety; eliminating surcharge for and stacked letters on veteran  
1.2 license plates; authorizing donation for education on anatomical gifts with vehicle  
1.3 registration tax; creating anatomical gift account; clarifying and conforming  
1.4 provisions regarding driver's license revocation periods for DWI convictions;  
1.5 providing for acceptable methods of payment and surcharge on driver's licenses;  
1.6 authorizing a fee for motor vehicle title searches and appropriating that amount  
1.7 to the Department of Public Safety; amending Minnesota Statutes 2010, sections  
1.8 168.013, by adding a subdivision; 168.123, subdivision 2; 168A.07, subdivision  
1.9 1; 169A.54, subdivisions 1, 6; 171.061, subdivision 4; 171.30, subdivision 1;

1.14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.15 Section 1. Minnesota Statutes 2010, section 168.013, is amended by adding a  
1.16 subdivision to read:

1.17 Subd. 22. **Optional donation for education on anatomical gifts.** As part of  
1.18 procedures for payment of the vehicle registration tax under this section, the commissioner  
1.19 shall allow a vehicle owner to add the tax, a \$2 donation for the purposes of public  
1.20 information and education on anatomical gifts under section 171.075, for in-person  
1.21 transactions conducted by a deputy registrar appointed under section 168.33, subdivision  
1.22 2. This subdivision applies to annual renewal registrations only, and does not apply to  
1.23 registrations authorized under sections 168.053 to 168.057, 168.127, 168.187, and 168.27.

1.24 **EFFECTIVE DATE.** This section is effective January 1, 2013.

3.5 24, recreational motor vehicle as defined in section 168.002, subdivision 27, or one-ton

3.7 motor vehicle as defined in section 169.011, subdivision 16; or

4.8 (c) For a veteran who served during ~~World War I or~~ World War II, the plates must  
4.9 bear the inscription "WORLD WAR VET" ~~and:~~

5.5 ~~and "V" with the first letter directly above the second letter and both letters just preceding~~  
5.6 ~~the first numeral of the special plate number.~~

5.7 (h) For a veteran who is the recipient of:

5.8 (1) the Iraq Campaign Medal, the special plates must be inscribed with a facsimile of  
5.9 that medal and must bear the inscription "IRAQ WAR VET" directly below the special  
5.10 plate number;

5.11 (2) the Afghanistan Campaign Medal, the special plates must be inscribed with a  
5.12 facsimile of that medal and must bear the inscription "AFGHAN WAR VET" directly  
5.13 below the special plate number;

5.14 (3) the Global War on Terrorism Expeditionary Medal, the special plates must  
5.15 be inscribed with a facsimile of that medal and must bear the inscription "GWOT  
5.16 VETERAN" directly below the special plate number; or

5.19 (i) For a veteran who is the recipient of the Global War on Terrorism Service Medal,

5.22 any member of the National Guard or other military reserves who has been ordered to  
5.23 federally funded state active service under United States Code, title 32, as defined in  
5.24 section 190.05, subdivision 5b, and who is the recipient of the Global War on Terrorism  
5.25 Service Medal, is eligible for the license plate described in this paragraph, irrespective of

5.30 (k) For a veteran who is a recipient of the Bronze Star medal, the plates must bear  
5.31 the inscription "BRONZE STAR VET" and have a facsimile or an emblem of the official  
5.32 Bronze Star medal.

5.33 (l) For a veteran who is a recipient of the Silver Star medal, the plates must bear  
5.34 the inscription "SILVER STAR VET" and have a facsimile or an emblem of the official  
5.35 Silver Star medal.

6.3 application is made in this state for a certificate of title on a vehicle and the department is  
6.4 not satisfied as to the ownership of the vehicle or the existence of security interests therein,  
6.5 the vehicle may be registered but the department shall either:

6.6 (1) withhold issuance of a certificate of title until the applicant shall present  
6.7 documents reasonably sufficient to satisfy the department of the applicant's ownership of  
6.8 the vehicle and as to any security interest therein; or

6.9 (2) as a condition to issuing a certificate of title;

6.10 (i) notify, by certified mail, prior owners of or holders of a security interest in the

6.19 the department and executed by the applicant, and either accompanied by the deposit of  
6.20 cash or executed by a surety company authorized to do business in this state, in an amount  
6.21 equal to 1-1/2 times the value of the vehicle as determined by the department. The bond  
6.22 shall be conditioned to indemnify any prior owner and secured party and any subsequent  
6.23 purchaser of the vehicle or person acquiring any security interest therein, or the successor  
6.24 in interest of any said person, against any expense, loss, or damage, including reasonable  
6.25 attorneys' fees, by reason of the issuance of the certificate of title to the vehicle or on  
6.26 account of any defect in or undisclosed security interest upon the right, title and interest  
6.27 of the applicant in and to the vehicle. Any such interested person shall have a right  
6.28 of action to recover on such bond for any breach of its conditions, but the aggregate  
6.29 liability of the surety to all such persons shall in no event exceed the amount of the bond.  
6.30 Unless the department has been notified of the pendency of an action to recover on the  
6.31 bond and if all questions as to ownership and outstanding security interests have been  
6.32 resolved to the satisfaction of the department, such bond, and any deposit accompanying
