1.5	Section 1. MINNESOTA TANF EXPENDITURES TASK FORCE.
1.6	Subdivision 1. Establishment. The Minnesota TANF Expenditures Task Force is
1.7	established to analyze past temporary assistance for needy families (TANF) expenditures
1.8	and make recommendations as to which, if any, programs currently receiving TANF
1.9	funding should be funded by the general fund so that a greater portion of TANF funds
1.10	can go directly to Minnesota families receiving assistance through the Minnesota family
1.11	investment program under Minnesota Statutes, chapter 256J.
1.12	Subd. 2. Membership; meetings; staff. (a) The task force shall be composed of the
1.13	following members who serve at the pleasure of their appointing authority:
1.14	(1) one representative of the Department of Human Services appointed by the
1.15	commissioner of human services;
1.16	(2) one representative of the Department of Management and Budget appointed by
1.17	the commissioner of management and budget;
1.18	(3) two representatives of county government appointed by the Association of
1.19	Minnesota Counties, one representing counties in the seven-county metropolitan area

1.21	(4) one representative of the Minnesota Legal Services Coalition;
1.22	(5) one representative of the Children's Defense Fund of Minnesota;

2.6	shall serve without compensation or reimbursement of expenses.
2.7	(c) The commissioner of human services must convene the first meeting of the

2.9	least quarterly.
2.10	(d) Staffing and technical assistance shall be provided by the Department of Human

2.31	(b) In preparing the recommendations under paragraph (a), the task force shall
2.32	consult with appropriate Department of Human Services information technology staff

2.34	Subd. 4. Report. (a) The task force must submit an initial report by November
2.35	30, 2014, on past expenditures of the TANF block grant in Minnesota to the chairs and
