(d) Substitute teacher pay must be equal to or greater than 90 percent of the starting salary for licensed teachers in the school district.

- (e) If the school building substitute teacher is unavailable for a classroom, supervisory personnel must be assigned to perform substitute teaching prior to reassigning a licensed teacher as a substitute classroom teacher. In the event that a licensed teacher serves as a substitute classroom teacher during their designated preparation time, that teacher must receive pay for the classroom period spent substitute teaching that is not less than twice the hourly rate of pay for that teacher, in addition to any preparation time required. Payment must be made no later than the following pay period.
- (f) Notwithstanding any law to the contrary, supervisory personnel under section 122A.15,
 subdivision 2, including athletic coaches, must serve as a substitute teacher no less than
 twice per school year.
