Section 1. DIRECTION TO COMMISSIONER; PERMITTING OVERTIME

REIMBURSEMENT FOR PERSONAL CARE ASSISTANTS AND

COMMUNITY-FIRST SERVICES AND SUPPORTS WORKERS.

(a) By January 1, 2024, the commissioner of human services, in consultation with staff

from the Office of the Revisor of Statutes; House Research Department; House Fiscal

Analysis; and the Office of Senate Counsel, Research and Fiscal Analysis, shall prepare

legislation for introduction in the 2024 legislative session proposing the statutory changes
