BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

## Section 1. [626.8474] DOMESTIC VIOLENCE POLICY.

Subdivision 1. **Statewide model policy.** (a) By October 15, 2018, the board shall develop 1.7 and distribute to all chief law enforcement officers a comprehensive model policy governing 1.8 procedures and strategies for addressing domestic violence prevention and acts of domestic 1.9 violence committed by peace officers and civilian employees of a state or local law 1.10 enforcement agency and high-profile persons including, at a minimum, elected officials, 1.11 high-level government appointees, media or sports figures, and entertainers. The board shall 1.12 convene a working group to develop the model policy. The working group shall include, at 1.13 a minimum, representatives of the board, the Minnesota Coalition of Battered Women, the 1.14 1.15 Minnesota Coalition Against Sexual Assault, the Minnesota Police and Peace Officers Association, the Minnesota Sheriffs' Association, the Minnesota Chiefs of Police Association, 1.16 the Office of Crime Victim Services in the Minnesota Department of Public Safety, the 1.17 League of Minnesota Cities, the Association of Minnesota Counties, and the Minnesota 1.18 County Attorneys Association. 1.19 (b) The policy shall, at a minimum, include the following components: 1.20
