In lieu of the tax imposed in subdivision 1, 1.11 there is imposed a tax of \$150 on the purchase price of a passenger automobile, motorcycle, 1.12 or a fire truck described in section 297B.025, subdivision 2. 1.13 Sec. 3. Minnesota Statutes 2018, section 297B.025, subdivision 1, is amended to read: 1.14 Subdivision 1. Noncollector vehicle. Purchase or use of a passenger automobile as 1.15 defined in section 168.002, subdivision 24, shall be taxed pursuant to section 297B.02, 1.16 subdivision 2, if the passenger automobile or motorcycle (1) is in the tenth or subsequent 1.17 year of vehicle life, and (2) does not have a resale value of \$3,000 or more, as determined 1.18 using nationally recognized sources of information on automobile resale values, as designated 1.19 by the registrar of motor vehicles. 1.20
