- Subd. 4. **Approval process.** (a) The commissioner of education must appoint an advisory committee to review the applications and to recommend approval for those applications that meet the requirements of this section. The commissioner of education has final authority over application approvals.
- (b) To the extent practicable, the commissioner must ensure an equitable geographicdistribution of approved P-TECH schools.
- (c) The commissioner must first begin approving applications for a P-TECH school
 enrolling students in the 2020-2021 school year or later.

- Subd. 5. **P-TECH support**, start-up, and mentoring grants. (a) When an appropriation is available, each P-TECH school is eligible for a grant to support start-up and ongoing program costs, which may include, but are not limited to, recruitment, student support, program materials, and P-TECH school liaisons. A P-TECH school may form a partnership with a school in another school district.
- (b) For fiscal year 2026 and later, the maximum P-TECH support grant must not exceed
 \$500,000 per year. A support grant may be awarded for a period not to exceed two years.
 Beginning in fiscal year 2028, all P-TECH support grants must be awarded on a competitive grant basis.
- (c) An approved P-TECH school is eligible to receive a grant to support start-up costs the year before first enrolling P-TECH students. A start-up grant may be awarded to a new applicant in an amount not to exceed \$50,000.
