of state bonds. 1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.5 Section 1. RICE CREEK RAILROAD BRIDGE. 1.6 Subdivision 1. **Appropriation.** (a) \$1,550,000 is appropriated from the bond proceeds 1.7 fund to the commissioner of transportation for a grant to Minnesota Commercial Railway 1.8 Company to demolish the existing railroad bridge over Rice Creek in the city of New 1.9 Brighton and to predesign, design, acquire any needed right-of-way, engineer, construct, 1 10 and equip a replacement railroad bridge to meet the needs of the railroad operators that use 1.11 the bridge, as authorized by the Minnesota Constitution, article XI, section 5, paragraph (i). 1.12 This appropriation is subject to Minnesota Statutes, section 16A.642, and is available when 1.13 the commissioner of management and budget determines that sufficient resources have been 1.14 1.15 committed to complete the project, as required by Minnesota Statutes, section 16A.502.
