1.8	Section 1. Minnesota Statutes 2022, section 18B.01, is amended by adding a subdivision
1.9	to read:
1.10	Subd. 1d. Application or use of a pesticide. "Application or use of a pesticide" includes:
1.11	(1) the dispersal of a pesticide on, in, at, or directed toward a target site;
1.12	(2) preapplication activities that involve the mixing and loading of a restricted use
1.13	pesticide; and
1.14	(3) other restricted use pesticide-related activities, including but not limited to transporting
1.15	or storing pesticide containers that have been opened; cleaning equipment; and disposing
1.16	of excess pesticides, spray mix, equipment wash waters, pesticide containers, and other
1.17	materials that contain pesticide.
1.18	Sec. 2. Minnesota Statutes 2022, section 18B.305, subdivision 2, is amended to read:
1.19	Subd. 2. Training manual and examination development. The commissioner, in
1.20	consultation with University of Minnesota Extension and other higher education institutions,
1.21	shall continually revise and update pesticide applicator training manuals and examinations.

3.9	(1) has the necessary qualifications in the practical selection and application of pesticides;
3.10	(2) has passed a closed-book examination given by the commissioner; and
3.11	(3) is engaged as an employee of or is working under the direction of a person licensed
3.12	as a master under a structural pest control license.
3.13	(d) The commissioner may license a person as a fumigator under a structural pest control
3.14	license if the person:
3.15	(1) has knowledge of the practical selection and application of fumigants;
3.16	(2) has passed a closed-book examination given by the commissioner; and
3.17	(3) is licensed by the commissioner as a master or journeyman under a structural pest
3.18	control license.
3.19	Sec. 5. Minnesota Statutes 2022, section 18B.32, subdivision 4, is amended to read:
3.20	Subd. 4. Renewal. (a) A structural pest control applicator license may be renewed on
3.21	or before the expiration of an existing license subject to reexamination, attendance at
3.22	workshops a recertification workshop approved by the commissioner, or other requirements
3.23	imposed by the commissioner to provide the applicator with information regarding changing
3.24	technology and to help assure a continuing level of competency and ability to use pesticides
3.25	safely and properly. A recertification workshop must meet or exceed the competency

9.7 (e) A copy of the record must be given to a person who ordered the application that is
9.8 present at the site where the structural pest control application is conducted, placed in a
9.9 conspicuous location at the site where the structural pest control application is conducted
9.10 immediately after the application of the pesticides, or delivered to the person who ordered
9.11 an application or the owner of the site. The commissioner must make sample forms available
