BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. [626.8479] CHILD PROTECTION TRAINING.

Subdivision 1. Learning objectives. By January 1, 2025, the board must create learning objectives for preservice and in-service training to educate and prepare peace officers in the area of child protection. The objectives must address the applicable laws and policies governing a peace officer's role in child protection matters and practical issues that officers are likely to encounter in the field. The learning objectives must be updated as the board considers appropriate.

- Subd. 2. Preservice training required. (a) The learning objectives developed pursuant to subdivision 1 must be included in the required curriculum of professional peace officer educational programs.
- (b) A person is not eligible to take the peace officer licensing examination after July 1, 2026, unless the individual has received the training described in paragraph (a).
- Subd. 3. In-service training required. Beginning July 1, 2025, the chief law enforcement 1.17 officer of every state and local law enforcement agency shall provide in-service child 1.18 protection training to every peace officer and part-time peace officer employed by the 1.19 1.20 agency. The training must comply with the learning objectives developed and approved by the board and must meet board requirements for board-approved continuing education credit. 1.21 The training must consist of at least six continuing education credits of the credits required 1.22
