1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. APPROPRIATION; EMERGENCY SERVICES.
1.6	(a) \$9,000,000 in fiscal year 2021 is appropriated from the general fund to the
1.7	commissioner of human services for emergency services grants under Minnesota Statutes,
1.8	section 256E.36. Grant money may be used to:
1.9	(1) provide housing that promotes health and safety or to isolate homeless individuals
1.10	exposed to COVID-19 or who are experiencing a respiratory illness, including grant money
1.11	to provide additional shelter space, to purchase vouchers for the cost of a motel or hotel
1.12	room, or to fund other housing options. Vouchers for the cost of a motel or hotel room must
1.13	not be issued to motels or hotels that receive funding from another source for the cost of
1.14	the same motel or hotel room for the same date;
1.15	(2) purchase hygiene, sanitation, and cleaning supplies to comply with Centers for
1.16	Disease Control and Prevention guidance on sanitation and personal protective equipment;
1.17	and
1.18	(3) hire staff necessary to protect the health and wellness of program recipients, to
1.19	increase the number of persons served, or to provide staffing when workers are quarantined
1.20	or cannot work because they are caring for someone with COVID-19.
1.21	(b) Notwithstanding any other law to the contrary, the commissioner of human services
1.22	may allocate money to programs, providers, and organizations providing or seeking to

2.3	(c) Grant applicants must describe how the applicants intend to use grant money for the

2.6	(d) This is a onetime appropriation and is available until June 30, 2021, or until 60 days

2.14	or confirmed COVID-19-positive individuals who are experiencing homelessness or who
2.15	cannot safely isolate at home and who do not require a hospital level of care.
2.16	(b) The commissioner of human services may enter into contracts or directly purchase
2.17	goods or services necessary to provide isolation spaces or services related to establishing
2.18	or maintaining such spaces. The commissioner of human services may enter into contracts
2.19	under this paragraph with local units of government as defined in Minnesota Statutes, section
2.20	4A.07, subdivision 1, paragraph (a); tribal governments; and nonprofit organizations.
