Federal adjusted gross income shall not be reduced by the amount of a net operating loss carryback or carryforward or a capital loss carryback or carryforward allowed for the year.

- (3) to the extent included in federal adjusted gross income, amounts contributed by the claimant or spouse to a traditional <u>retirement account or plan</u> or Roth style retirement account or plan, but not to exceed the retirement base amount reduced by the amount of contributions excluded from federal adjusted gross income, but not less than zero;
