1.11	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.12	Section 1. Minnesota Statutes 2020, section 168.021, subdivision 2a, is amended to read:
1.13	Subd. 2a. Plate transfer. (a) When ownership of a vehicle described in subdivision 1,
1.14	is transferred, the owner of the vehicle shall remove the disability plate or plates. The buyer
1.15	of the motor vehicle is entitled to receive a regular plate or plates for the vehicle without
1.16	further cost for the remainder of the registration period.
1.17	(b) Notwithstanding section 168.12, subdivision 1, the disability plate or plates may be
1.18	transferred to a replacement vehicle on notification to the commissioner. However, the
1.19	disability plate or plates may not be transferred without a fee unless the replacement vehicle
1.20	(1) is listed under section 168.012, subdivision 1, and, in case of a single plate for a
1.21	motorcycle or a motorized bicycle, the replacement vehicle is a motorcycle or a motorized
1.22	bicycle, and (2) is owned or primarily operated by the permanently physically disabled
1.23	person.

Sec. 2. Minnesota Statutes 2020, section 168.10, subdivision 1i, is amended to read:

Subd. 1i. Collector plate transfer. Notwithstanding section 168.12, subdivision 1, on 2.2 payment of a transfer fee of \$5, plates issued under this section may be transferred to another 2.3 vehicle owned or jointly owned by the person to whom the special plates were issued or 2.4 the plate may be assigned to another owner. In addition to the transfer fee required by section 2.5 168.12, subdivision 1, a new owner must pay the \$25 tax and any fee required by section 2.6 168.12, subdivision 2a. The \$5 fee must be paid into the state treasury and credited to the 2.7 vehicle services operating account under section 299A.705, subdivision 1. License plates 2.8 issued under this section may not be transferred to a vehicle not eligible for the collector's 2.9 vehicle license plates. 2.10

2.11 Sec. 3. Minnesota Statutes 2020, section 168.12, subdivision 1, is amended to read:

2.12 Subdivision 1. **Plates; design, visibility, periods of issuance.** (a) The commissioner, 2.13 upon approval and payment, shall issue to the applicant the plates required by this chapter, 2.14 bearing the state name and an assigned vehicle registration number. The number assigned 2.15 by the commissioner may be a combination of a letter or sign with figures. The color of the 2.16 plates and the color of the abbreviation of the state name and the number assigned must be 2.17 in marked contrast. The plates must be lettered, spaced, or distinguished to suitably indicate 2.18 the registration of the vehicle according to the rules of the commissioner.

(b) When a vehicle is registered on the basis of total gross weight, the plates issued must

painted number plates. When properly mounted on an unlighted vehicle, the plates, when
viewed from a vehicle equipped with standard headlights, must be visible for a distance of
not less than 1,500 feet and readable for a distance of not less than 110 feet.

2.30 (f) The commissioner shall issue plates for the following periods:

(1) New plates issued pursuant to section 168.012, subdivision 1, must be issued to a
vehicle for as long as the vehicle is owned by the exempt agency and the plate shall not be

transferable from one vehicle to another but the plate may be transferred with the vehiclefrom one tax-exempt agency to another.

3.3 (2) Plates issued for passenger automobiles must be issued for a seven-year period. All
3.4 plates issued under this paragraph must be replaced if they are seven years old or older at
3.5 the time of registration renewal or will become so during the registration period.

3.6 (3) Plates issued under sections 168.053 and 168.27, subdivisions 16 and 17, must be
3.7 for a seven-year period.

3.8 (4) Plates issued under subdivisions 2c and 2d and section 168.123 must be issued for
3.9 the life of the veteran under section 169.79.

3.10 (5) Plates for any vehicle not specified in clauses (1) to (3) must be issued for the life3.11 of the vehicle.

(g) In a year in which plates are not issued, the commissioner shall issue for each
registration a sticker to designate the year of registration. This sticker must show the year
or years for which the sticker is issued, and is valid only for that period. The plates and
stickers issued for a vehicle may not be transferred to another vehicle during the period for
which the sticker is issued, except when issued for a vehicle registered under section 168.187.

3.17 (h) Despite any other provision of this subdivision, plates issued to a vehicle used for
3.18 behind-the-wheel instruction in a driver education course in a public school may be
3.19 transferred to another vehicle used for the same purpose without payment of any additional
3.20 fee. The public school shall notify the commissioner of each transfer of plates under this

(i) Except as otherwise prohibited, a person may transfer license plates to different
vehicles owned or jointly owned by the person to whom the plates were issued. The person
transferring the plates must pay a transfer fee of \$5. The \$5 fee must be paid into the state
treasury and credited to the vehicle services operating account under section 299A.705,
subdivision 1. Special license plates issued under this chapter must not be transferred to a
vehicle that is not eligible for that type of special license plates.

Subd. 4. **Plates transfer.** (a) On payment of a fee of \$5, plates issued under subdivision 1, paragraph (a), clause (1), may be transferred to another passenger automobile or recreational motor vehicle, or one-ton truck described in subdivision 1, paragraph (a), clause (1), registered to the individual to whom the plates were issued.

Subd. 5. **Transfer.** On payment of a fee of \$5 and notification to the commissioner, special plates issued under this section may be transferred to another motor vehicle owned or jointly owned by the eligible person.

Subd. 3. **Plate transfers.** Despite section 168.12, subdivision 1, on payment of a transfer fee of \$5, plates issued under this section may be transferred to another passenger automobile registered to the individual to whom the veteran contribution plates were issued, or a single motorcycle plate may be transferred to another motorcycle registered to the individual to whom the plate was issued.

168.1294 LAW ENFORCEMENT MEMORIAL PLATES.

Subd. 3. **Plates transfer.** On application to the commissioner and payment of a transfer fee of \$5, special plates may be transferred to another qualified motor vehicle that is registered to the same individual to whom the special plates were originally issued.

168.1295 STATE PARKS AND TRAILS PLATES.

Subd. 4. **Plate transfers.** Notwithstanding section 168.12, subdivision 1, on payment of a transfer fee of \$5, plates issued under this section may be transferred to another passenger automobile registered to the person to whom the plates were issued.

Subd. 4. **Plate transfers.** Notwithstanding section 168.12, subdivision 1, on payment of a transfer fee of \$5, plates issued under this section may be transferred to another passenger automobile, one-ton pickup truck, recreational vehicle, or motorcycle owned by the individual to whom the special plates were issued.

Subd. 3. **Plates transfer.** On payment of a fee of \$5, plates issued under this section may be transferred to another passenger automobile, one-ton pickup truck, motorcycle, or other recreational vehicle registered to the individual to whom the special plates were issued.
