1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. JACKSON COUNTY AUDITOR-TREASURER OFFICE MAY BE
1.7	APPOINTED.
1.8	Subdivision 1. Authority to make office appointive. Notwithstanding Minnesota
1.9	Statutes, section 382.01, upon adoption of a resolution by the Jackson County Board of
1.10	Commissioners, the office of county auditor-treasurer is not elective but must be filled by
1.11	appointment by the county board as provided in the resolution.
1.12	Subd. 2. Board controls; may change as long as duties done. Upon adoption of
1.13	a resolution by the county board of commissioners and subject to subdivisions 3 and 4,
1.14	the duties of an elected official required by statute whose office is made appointive as
1.15	authorized by this section must be discharged by the county board of commissioners
1.16	acting through a department head appointed by the board for that purpose. Reorganization,
1.17	reallocation, delegation, or other administrative change or transfer does not diminish,
1.18	prohibit, or avoid the discharge of duties required by statute.
1.19	Subd. 3. Incumbents to complete term. The person elected at the last general
1.20	election to an office made appointive under this section must serve in that capacity and
1.21	perform the duties, functions, and responsibilities required by statute until the completion
1.22	of the term of office to which the person was elected or until a vacancy occurs in the
1.23	office, whichever occurs earlier.

2.1	Subd. 4. Publishing resolution; petition, referendum. (a) Before the adoption of
2.2	the resolution to provide for the appointment of the county auditor-treasurer, the county
2.3	board must publish a proposed resolution notifying the public of its intent to consider the
2.4	issue once each week for two consecutive weeks in the official publication of the county.
2.5	Following publication and prior to formally adopting the resolution, the county board shall
2.6	provide an opportunity at its next regular meeting for public comment relating to the issue.
2.7	After the public comment opportunity, at the same meeting or a subsequent meeting, the
2.8	county board of commissioners may adopt a resolution that provides for the appointment
2.9	of the county auditor-treasurer as permitted in this section. The resolution must be
