1.5 WHEREAS, Governor Walz signed Executive Order 20-01, a declaration of a peacetime

1.6 emergency on March 13, 2020; and

1.7 WHEREAS, the Executive Council of the State extended that peacetime emergency for up

1.8 to 30 days on March 16, 2020; and

1.9 WHEREAS, on April 13, 2020, by Executive Order 20-35, Governor Walz extended the

1.10 peacetime public emergency declared under Executive Order 20-01 until May 13, 2020; and

1.11 WHEREAS, on May 13, 2020, by Executive Order 20-53, Governor Walz extended the

1.12 peacetime public emergency declared under Executive Order 20-01 and extended in Executive

1.13 Order 20-35 until June 12, 2020; and

1.14 WHEREAS, on June 12, 2020, by Executive Order 20-75, Governor Walz extended the

1.15 peacetime public emergency declared under Executive Order 20-01 and extended in Executive

1.16 Orders 20-35 and 20-53 until July 13, 2020; and

1.17 WHEREAS, on July 13, 2020, by Executive Order 20-78, Governor Walz extended the

1.18 peacetime public emergency declared under Executive Order 20-01 and extended in Executive

1.19 Orders 20-35, 20-53, and 20-75 until August 12, 2020; and

1.20 WHEREAS, on August 12, 2020, by Executive Order 20-83, Governor Walz extended the

1.21 peacetime public emergency declared under Executive Order 20-01 and extended in Executive

1.22 Orders 20-35, 20-53, 20-75, and 20-78 until September 11, 2020; and

2.1 WHEREAS, on September, 11, 2020, by Executive Order 20-89, Governor Walz extended  
2.2 the peacetime public emergency declared under Executive Order 20-01 and extended in Executive  
2.3 Orders 20-35, 20-53, 20-75, 20-78, and 20-83 until October 12, 2020; and

2.4 WHEREAS, on October, 12, 2020, by Executive Order 20-92, Governor Walz extended the  
2.5 peacetime public emergency declared under Executive Order 20-01 and extended in Executive  
2.6 Orders 20-35, 20-53, 20-75, 20-78, 20-83, and 20-89 until November 12, 2020; and

2.7 WHEREAS, on November 12, 2020, by Executive Order 20-97, Governor Walz extended  
2.8 the peacetime public emergency declared under Executive Order 20-01 and extended in Executive  
2.9 Orders 20-35, 20-53, 20-75, 20-78, 20-83, 20-89, and 20-92 until December 14, 2020; and

2.10 WHEREAS, on December 14, 2020, by Executive Order 20-100, Governor Walz extended  
2.11 the peacetime public emergency declared under Executive Order 20-01 and extended in Executive  
2.12 Orders 20-35, 20-53, 20-75, 20-78, 20-83, 20-89, 20-92, and 20-97 until January 13, 2021; and

2.13 WHEREAS, on January 13, 2021, by Executive Order 21-04, Governor Walz extended the  
2.14 peacetime public emergency declared under Executive Order 20-01 and extended in Executive  
2.15 Orders 20-35, 20-53, 20-75, 20-78, 20-83, 20-89, 20-92, 20-97, and 20-100 until February 12, 2021;  
2.16 NOW, THEREFORE,

2.17 BE IT RESOLVED by the House of Representatives of the State of Minnesota, the Senate  
2.18 concurring, that the legislature exercises its authority under Minnesota Statutes, section 12.31,  
2.19 subdivision 2, paragraph (b), terminating the peacetime emergency declared under Executive Order  
2.20 20-01.

2.21 BE IT FURTHER RESOLVED that the Chief Clerk of the House of Representatives is  
2.22 directed to prepare an enrolled copy of this resolution, to be authenticated by his signature and  
2.23 those of the Speaker of the House of Representatives, the Chair of the Senate Rules and  
2.24 Administration Committee, and the Secretary of the Senate, and transmit it to the Governor of the  
2.25 State of Minnesota.
