1.5	Section 1. Minnesota Statutes 2016, section 275.025, subdivision 1, is amended to read:
1.6	Subdivision 1. Levy amount. The state general levy is levied against
1.7	commercial-industrial property and seasonal residential recreational property, as defined
1.8	in this section. The state general levy base amount is \$592,000,000 \$862,551,000 for taxes
1.9	payable in 2002. For taxes payable in subsequent years, the levy base amount is increased
1.10	each year by multiplying the levy base amount for the prior year by the sum of one plus the
1.11	rate of increase, if any, in the implicit price deflator for government consumption
1.12	expenditures and gross investment for state and local governments prepared by the Bureau
1.13	of Economic Analysts of the United States Department of Commerce for the 12-month
1.14	period ending March 31 of the year prior to the year the taxes are payable 2018 and thereafter.
