1.8	Section 1. Minnesota Statutes 2014, section 122A.245, subdivision 1, is amended to

1.10	Subdivision 1. Requirements. (a) To improve academic excellence, improve ethnic				
1.11	and cultural diversity in the classroom, and close the academic achievement gap, the				
1.12	Board of Teaching must approve qualified teacher preparation programs under this section				
1.13	that are a means to acquire a two-year limited-term license, which the board may renew				
1.14	one time for an additional one-year term, and to prepare for acquiring a standard license.				
1.15	The following entities are eligible to participate under this section:				
1.16	(1) a school district or charter school that forms a partnership with a college or

(a) The first three consecutive years of a teacher's 2.10 2.11 first teaching experience in Minnesota in a single district is deemed to be a probationary period of employment, and, the probationary period in each district in which the teacher is 2.12 thereafter employed shall be one year. The school board must adopt a plan for written 2.13 evaluation of teachers during the probationary period that is consistent with subdivision 2.14 8. Evaluation must occur at least three times periodically throughout each school year 2.15 for a teacher performing services during that school year; the first evaluation must occur 2.16 within the first 90 days of teaching service. Days devoted to parent-teacher conferences, 2.17 teachers' workshops, and other staff development opportunities and days on which a 2.18 teacher is absent from school must not be included in determining the number of school 2.19 days on which a teacher performs services. Except as otherwise provided in paragraph 2.20 (b), during the probationary period any annual contract with any teacher may or may not 2.21 be renewed (1) as the school board shall see fit, or (2) consistent with the negotiated 2.22 unrequested leave of absence plan in effect under subdivision 10.
