3.21	(g) The commissioner is authorized to accept applications from additional nonprofit

3.23	(h) Lenders participating in the program must provide quarterly reports of small business

1.5	must not be used to refinance debt that existed at the time of the governor's COVID-19
1.6	peacetime emergency declaration. No matching contribution is required.

1.15	clause: (i) may be made for up to \$250,000 per operator, and of that amount, all but \$20,000
1.16	of the loan must be made as credits to existing tenants of the operator; (ii) must be used
1.17	primarily for maintaining existing tenants; and (iii) require that at least 40 percent of the
1.18	loan be used to forgive the rent of existing tenants. A tenant who receives benefits from this
1.19	loan is subject to the requirements in paragraph (i), clauses (1) to (4), only.
1.20	(k) Eligible businesses may not receive more than one loan under this section.
1.21	(l) The commissioner may develop criteria, forms, applications, and reporting
1.22	requirements for use by the lenders in paragraph (c).
1.23	(m) All loan recipients must include as part of their applications a business plan that
1.24	includes a path for continued operations and success in repayment of the loan.
1.25	(n) Loans and the process of making loans under this section are exempt from Minnesota
1.26	Statutes, sections 16A.15, subdivision 3; 16B.97; and 16B.98, subdivisions 5, 7, and 8. The
1.27	commissioner must audit the use of loan funds under this section in accordance with standard
1.28	accounting practices. The exemptions under this paragraph expire on December 30, 2021.
1.29	(o) Any funds not spent by the lenders in paragraph (c) by December 31, 2021, must be
1.30	returned to the department to be canceled back to the general fund.
