1.7	Section 1. [214.078] PROTECTION FROM CONVERSION THERAPY ACT.
1.8	Subdivision 1. Definition. "Conversion therapy" means any practice by a mental
1.9	health practitioner or mental health professional as defined in section 245.462 that is
1.10	intended to change an individual's sexual orientation, or intended to discourage a transition
1.11	from one gender to another. This includes efforts to eliminate or reduce sexual or romantic
1.12	attractions or feelings toward individuals of the same sex. Conversion therapy does not
1.13	include: (1) counseling that provides assistance to a person seeking to transition from one
1.14	gender to another; (2) counseling that facilitates a client's coping skills, social support, and
1.15	identity exploration and development; or (3) sexual orientation-neutral interventions to
1.16	prevent or address unlawful conduct or unsafe sexual practices.
