1.9	(a) In 1965, United States Steel Corporation conveyed land to the state of Minnesota
1.10	that was included in the Soudan underground mine state park, with certain lands at Stuntz
1.11	Bay subject to leases outstanding for employee boathouse sites.
1.12	(b) Notwithstanding Minnesota Statutes, sections 85.011, 85.012, subdivision 1, and
1.13	86A.05, subdivision 2, upon the expiration of a boathouse lease described under paragraph
1.14	(a), the commissioner of natural resources shall offer a new lease to the party in possession
1.15	at the time of lease expiration, or, if there has been a miscellaneous lease issued by the
1.16	Department of Natural Resources due to expiration of a lease described under paragraph
1.17	(a), upon its expiration to the lessee. The new lease shall be issued under the terms and
