1.9	Section 1. Minnesota Statutes 2010, section 84.82, subdivision 2, is amended to read:

1.11	registration or reregistration shall be made to the commissioner or, an authorized deputy
1.12	registrar of motor vehicles, or an agent appointed by the commissioner according to

1.14	and address of every owner of the snowmobile.
