commissioner shall collect a fee, to include a \$1 issuing fee for licensing agents, for issuing 3.1 a duplicate all-terrain vehicle safety certificate. The commissioner shall establish both fees 3.2 in a manner that neither significantly overrecovers nor underrecovers costs, including 3.3 overhead costs, involved in providing the services.
