1.7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.8	Section 1. [86B.841] TRANSFER-ON-DEATH TITLE TO WATERCRAFT.
1.9	Subdivision 1. Titled as transfer-on-death. A natural person who is the owner of a
1.10	watercraft may have the watercraft titled in transfer-on-death or TOD form by including in
1.11	the application for the certificate of title a designation of a beneficiary or beneficiaries to
1.12	whom the watercraft must be transferred on death of the owner or the last survivor of joint
1.13	owners with rights of survivorship, subject to the rights of secured parties.
1.14	Subd. 2. Designation of beneficiary. A watercraft is registered in transfer-on-death
1.15	form by designating on the certificate of title the name of the owner and the names
1.16	of joint owners with identification of rights of survivorship, followed by the words
1.17	"transfer-on-death to (name of beneficiary or beneficiaries)." The designation "TOD" may
1.18	be used instead of "transfer-on-death." A title in transfer-on-death form is not required
1.19	to be supported by consideration, and the certificate of title in which the designation
1.20	is made is not required to be delivered to the beneficiary or beneficiaries in order for
1.21	the designation to be effective.
1.22	Subd. 3. Interest of beneficiary. The transfer-on-death beneficiary or beneficiaries

(a) This section does not limit the rights of any 2.12 secured party or creditor of the owner of a watercraft against a transfer-on-death 2.13 beneficiary or beneficiaries. 2.14 (b) The state or a county agency with a claim or lien authorized by section 246.53, 2.15 256B.15, 261.04, or 270C.63, is a creditor for purposes of this subdivision. A claim 2.16 or lien under those sections continues to apply against the designated beneficiary or 2.17 beneficiaries after the transfer under this section if other assets of the deceased owner's 2.18 estate are insufficient to pay the amount of the claim. Subdivision 1. Titled as transfer-on-death. A natural person who is the owner of 2.24 a motor vehicle may have the motor vehicle titled in transfer-on-death or TOD form by 2.25 including in the application for the certificate of title a designation of a beneficiary or 2.26 beneficiaries to whom the motor vehicle must be transferred on death of the owner or the last 2.27 survivor of joint owners with rights of survivorship, subject to the rights of secured parties. 2.28 Subd. 2. Designation of beneficiary. A motor vehicle is registered in 2.29 transfer-on-death form by designating on the certificate of title the name of the owner and 2.30 the names of joint owners with identification of rights of survivorship, followed by the 2.31 words "transfer-on-death to (name of beneficiary or beneficiaries)." The designation "TOD" 2.32 may be used instead of "transfer-on-death." Vesting of ownership in beneficiary.
