1.14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.15 Section 1. Minnesota Statutes 2010, section 13.02, subdivision 6, is amended to read:

1.16 Subd. 6. **Designee.** "Designee" means any ~~person~~ individual designated by a  
1.17 responsible authority to be in charge of individual files or systems containing government  
1.18 data and to receive and comply with requests for government data.

1.19 Sec. 2. Minnesota Statutes 2010, section 13.02, subdivision 8, is amended to read:

1.20 Subd. 8. **Individual.** "Individual" means a ~~natural person~~ living human being. In  
1.21 the case of a minor or an incapacitated person as defined in section 524.5-102, subdivision  
1.22 6, "individual" includes a parent or guardian or an individual acting as a parent or guardian  
1.23 in the absence of a parent or guardian, except that the responsible authority shall withhold  
1.24 data from parents or guardians, or individuals acting as parents or guardians in the absence  
1.25 of parents or guardians, upon request by the minor if the responsible authority determines  
1.26 that withholding the data would be in the best interest of the minor.

2.1 Sec. 3. Minnesota Statutes 2010, section 13.02, subdivision 10, is amended to read:

2.2 Subd. 10. **Person.** "Person" means any individual, partnership, corporation,  
 2.3 association, business trust, ~~or a legal representative of an~~ public or private organization, or  
 2.4 government entity.

2.5 Sec. 4. Minnesota Statutes 2010, section 13.02, subdivision 16, is amended to read:

2.6 Subd. 16. **Responsible authority.** "Responsible authority" in a state agency or  
 2.7 statewide system means the state official designated by law or by the commissioner as  
 2.8 the individual responsible for the collection, use and dissemination of any set of data on  
 2.9 individuals, government data, or summary data. "Responsible authority" in any political  
 2.10 subdivision means the individual designated by the governing body of that political  
 2.11 subdivision as the individual responsible for the collection, use, and dissemination of  
 2.12 any set of data on individuals, government data, or summary data, or the chair of the  
 2.13 political subdivision's governing body if an individual is not designated, unless otherwise  
 2.14 provided by state law.

2.15 Sec. 5. Minnesota Statutes 2010, section 13.02, subdivision 19, is amended to read:

2.16 Subd. 19. **Summary data.** "Summary data" means statistical records and reports  
 2.17 derived from not public data on individuals but in which ~~individuals~~ persons are not  
 2.18 identified and from which neither their identities nor any other ~~characteristic~~ characteristics  
 2.19 that could uniquely identify ~~an individual is~~ them are ascertainable. Summary data are  
 2.20 not data derived solely from public data.

2.21 Sec. 6. **[13.025] GOVERNMENT ENTITY OBLIGATION.**

2.22 Subdivision 1. **Data inventory.** The responsible authority shall prepare an inventory  
 2.23 containing the authority's name, title, address, and a description of each category of  
 2.24 record, file, or process relating to private or confidential data on individuals maintained  
 2.25 by the authority's government entity. Forms used to collect private and confidential data  
 2.26 may be included in the inventory. Beginning August 1, 1977, and annually thereafter,  
 2.27 the responsible authority shall update the inventory and make any changes necessary  
 2.28 to maintain the accuracy of the inventory. The inventory shall be available from the  
 2.29 responsible authority to the public according to the provisions of sections 13.03 and  
 2.30 15.17. The commissioner may require responsible authorities to submit copies of the  
 2.31 inventory and may request additional information relevant to data collection practices,  
 2.32 policies, and procedures.

3.1 Subd. 2. **Public data access policy.** The responsible authority shall prepare a data  
 3.2 access policy and update it annually. The responsible authority shall make copies of the  
 3.3 policy easily available to the public by distributing free copies to the public or by posting  
 3.4 it in a conspicuous place within the government entity that is easily accessible to the  
 3.5 public or by posting it on the government entity's Web site.

3.6 Subd. 3. **Data subject rights and access policy.** The responsible authority shall  
 3.7 prepare a written policy of the rights of data subjects under section 13.04, and the specific  
 3.8 procedures used by the government entity for access by the data subject to public or  
 3.9 private data on individuals. The responsible authority shall make copies of the policy  
 3.10 easily available to the public by distributing free copies of it to the public or by posting it  
 3.11 in a conspicuous place within the government entity that is easily accessible to the public  
 3.12 or by posting it on the government entity's Web site.

3.13 Sec. 7. Minnesota Statutes 2010, section 13.03, subdivision 2, is amended to read:

3.14 Subd. 2. **Procedures.** (a) The responsible authority in every government entity shall  
 3.15 establish procedures, consistent with this chapter, to insure that requests for government  
 3.16 data are received and complied with in an appropriate and prompt manner.

3.17 ~~(b) The responsible authority shall prepare public access procedures in written form~~  
 3.18 ~~and update them no later than August 1 of each year as necessary to reflect any changes~~  
 3.19 ~~in personnel or circumstances that might affect public access to government data. The~~  
 3.20 ~~responsible authority shall make copies of the written public access procedures easily~~  
 3.21 ~~available to the public by distributing free copies of the procedures to the public or by~~  
 3.22 ~~posting a copy of the procedures in a conspicuous place within the government entity that~~

3.24 ~~(c)~~ (b) Full convenience and comprehensive accessibility shall be allowed to  
 3.25 researchers including historians, genealogists and other scholars to carry out extensive  
 3.26 research and complete copying of all records containing government data except as  
 3.27 otherwise expressly provided by law.

3.28 A responsible authority may designate one or more designees.

3.29 Sec. 8. Minnesota Statutes 2010, section 13.03, subdivision 3, is amended to read:

3.30 Subd. 3. **Request for access to data.** (a) Upon request to a responsible authority  
 3.31 or designee, a person shall be permitted to inspect and copy public government data at  
 3.32 reasonable times and places, and, upon request, shall be informed of the data's meaning. If  
 3.33 a person requests access for the purpose of inspection, the responsible authority may not  
 3.34 assess a charge or require the requesting person to pay a fee to inspect data. After a person

4.1 has received copies of the public data and has been informed of the meaning, the data need  
4.2 not be disclosed to that person for six months thereafter.

4.3 (b) For purposes of this section, "inspection" includes, but is not limited to, the  
4.4 visual inspection of paper and similar types of government data. Inspection does not  
4.5 include printing copies by the government entity, unless printing a copy is the only  
4.6 method to provide for inspection of the data. In the case of data stored in electronic form  
4.7 and made available in electronic form on a remote access basis to the public by the  
4.8 government entity, inspection includes remote access to the data by the public and the  
4.9 ability to print copies of or download the data on the public's own computer equipment.  
4.10 Nothing in this section prohibits a government entity from charging a reasonable fee for  
4.11 remote access to data under a specific statutory grant of authority. A government entity  
4.12 may charge a fee for remote access to data where either the data or the access is enhanced  
4.13 at the request of the person seeking access.

4.14 (c) The responsible authority or designee shall provide copies of public data upon  
4.15 request. If a person requests copies or electronic transmittal of the data to the person,  
4.16 the responsible authority may require the requesting person to pay the actual costs of  
4.17 searching for and retrieving government data, including the cost of employee time, and for  
4.18 making, certifying, and electronically transmitting the copies of the data or the data, but  
4.19 may not charge for separating public from not public data. However, if 100 or fewer pages  
4.20 of black and white, letter or legal size paper copies are requested, actual costs shall not be  
4.21 used, and instead, the responsible authority may charge no more than 25 cents for each  
4.22 page copied. If the responsible authority or designee is not able to provide copies at the  
4.23 time a request is made, copies shall be supplied as soon as reasonably possible.

4.24 (d) When a request under this subdivision involves any person's receipt of copies of  
4.25 public government data that ~~has~~ have commercial value and is a substantial and discrete  
4.26 portion of or an entire formula, pattern, compilation, program, device, method, technique,  
4.27 process, database, or system developed with a significant expenditure of public funds by  
4.28 the government entity, the responsible authority may charge a reasonable fee for the  
4.29 information in addition to the costs of making and certifying the copies. Any fee charged  
4.30 must be clearly demonstrated by the government entity to relate to the actual development  
4.31 costs of the information. The responsible authority, upon the request of any person, shall  
4.32 provide sufficient documentation to explain and justify the fee being charged.

4.33 (e) The responsible authority of a government entity that maintains public  
4.34 government data in a computer storage medium shall provide to any person making a  
4.35 request under this section a copy of any public data contained in that medium, in electronic  
4.36 form, if the government entity can reasonably make the copy or have a copy made.

5.1 This does not require a government entity to provide the data in an electronic format or  
 5.2 program that is different from the format or program in which the data are maintained  
 5.3 by the government entity. The entity may require the requesting person to pay the actual  
 5.4 cost of providing the copy.

5.5 (f) If the responsible authority or designee determines that the requested data ~~is~~  
 5.6 are classified so as to deny the requesting person access, the responsible authority or  
 5.7 designee shall inform the requesting person of the determination either orally at the time  
 5.8 of the request, or in writing as soon after that time as possible, and shall cite the specific  
 5.9 statutory section, temporary classification, or specific provision of federal law on which  
 5.10 the determination is based. Upon the request of any person denied access to data, the  
 5.11 responsible authority or designee shall certify in writing that the request has been denied  
 5.12 and cite the specific statutory section, temporary classification, or specific provision of  
 5.13 federal law upon which the denial was based.

5.14 (g) Electronic geospatial government data maintained by a government entity shall  
 5.15 be shared at no cost to government entities and federal and tribal government agencies.  
 5.16 Request for copies of the data under this section must be made to the government entity  
 5.17 that originally developed the data. Any data received by a government entity under this  
 5.18 subdivision may only be reproduced or redistributed as permitted by the government  
 5.19 entity that developed the data. Government entities are immune from civil liability for  
 5.20 any data shared at no cost as provided by this subdivision.

5.21 Sec. 9. Minnesota Statutes 2010, section 13.03, subdivision 4, is amended to read:

5.22 Subd. 4. **Change in classification of data; effect of dissemination among**  
 5.23 **agencies.** (a) The classification of a government entity's data in the possession of an entity  
 5.24 shall change if it is required to do so to comply with either judicial or administrative rules  
 5.25 pertaining to the conduct of legal actions or with a specific statute applicable to the data  
 5.26 in the possession of the disseminating or receiving entity.

5.27 (b) If data on individuals ~~is~~ are classified as both private and confidential by this  
 5.28 chapter, or any other statute or federal law, the data ~~is~~ are private.

5.29 (c) To the extent that government data ~~is~~ are disseminated to a government entity  
 5.30 by another government entity, the data disseminated shall have the same classification  
 5.31 ~~in the hands of at~~ at the entity receiving ~~it them~~ as it they had ~~in the hands of at~~  
 5.32 providing ~~it them~~ them.

5.33 (d) If a government entity disseminates data to another government entity, a  
 5.34 classification provided for by law ~~in the hands of at~~ at the entity receiving the data does not  
 5.35 affect the classification of the data ~~in the hands of at~~ at the entity that disseminates the data.

6.1 (e) To the extent that judicial branch data ~~is~~ are disseminated to government entities  
 6.2 by the judicial branch, the data disseminated shall have the same level of accessibility  
 6.3 ~~in the hands of the agency~~ at the government entity receiving it them as it they had  
 6.4 ~~in the hands of~~ at the judicial branch entity providing it them. If the data have a specific  
 6.5 classification in state statute or federal law, the government entity must maintain the  
 6.6 data according to the specific classification.

6.7 Sec. 10. Minnesota Statutes 2010, section 13.04, subdivision 4, is amended to read:

6.8 Subd. 4. **Procedure when data is not accurate or complete.** (a) An individual  
 6.9 subject of the data may ~~contest~~ challenge the accuracy or completeness of public or private  
 6.10 data. To exercise this right, an individual shall notify in writing the responsible authority  
 6.11 describing the nature of the disagreement. The responsible authority shall make a written  
 6.12 determination about the data challenge within 30 days and either: (1) correct the data  
 6.13 found to be inaccurate or incomplete and attempt to notify past recipients of inaccurate or  
 6.14 incomplete data, including recipients named by the individual; or (2) notify the individual  
 6.15 that the authority believes the data to be correct. Data in dispute shall be disclosed only if  
 6.16 the individual's statement of disagreement is included with the disclosed data.

6.17 The determination of the responsible authority may be appealed pursuant to the  
 6.18 provisions of the Administrative Procedure Act relating to contested cases. A data subject  
 6.19 cannot appeal a data challenge determination if the responsible authority corrects the  
 6.20 challenged data. The commissioner shall dismiss the appeal and provide written notice  
 6.21 to the individual if the individual challenged a policy, procedure, or process used by the  
 6.22 government entity. Upon receipt of an appeal by an individual, the commissioner shall,  
 6.23 before issuing the order and notice of a contested case hearing required by chapter 14,  
 6.24 try to resolve the dispute through education, conference, conciliation, or persuasion. If  
 6.25 the parties consent, the commissioner may refer the matter to mediation. Following these  
 6.26 efforts, the commissioner shall dismiss the appeal or issue the order and notice of hearing.

6.27 Copies of government data submitted to the commissioner by individuals appealing  
 6.28 a data challenge determination have the same classification as the data have when held  
 6.29 by the government entity.

6.30 (b) Data on individuals that have been successfully challenged by an individual  
 6.31 must be completed, corrected, or destroyed by a government entity without regard to the  
 6.32 requirements of section 138.17.

6.33 After completing, correcting, or destroying successfully challenged data, a  
 6.34 government entity may retain a copy of the commissioner of administration's order issued

7.1 under chapter 14 or, if no order were issued, a summary of the dispute between the parties  
7.2 that does not contain any particulars of the successfully challenged data.

7.3 Sec. 11. Minnesota Statutes 2010, section 13.05, subdivision 7, is amended to read:

7.4 Subd. 7. **Preparation of summary data.** The use of summary data derived from  
7.5 ~~private or confidential~~ not public data ~~on individuals~~ under the jurisdiction of one or more  
7.6 responsible authorities is permitted. Unless classified pursuant to section 13.06, another  
7.7 statute, or federal law, summary data ~~is~~ are public. The responsible authority shall prepare  
7.8 summary data from ~~private or confidential~~ not public data ~~on individuals~~ upon the request  
7.9 of any person if the request is in writing and the cost of preparing the summary data  
7.10 is borne by the requesting person. The responsible authority may delegate the power  
7.11 to prepare summary data (1) to the administrative officer responsible for any central  
7.12 repository of summary data; or (2) to a person outside of the entity if the person's purpose  
7.13 is set forth, in writing, and the person agrees not to disclose, and the entity reasonably  
7.14 determines that the access will not compromise ~~private or confidential~~ not public data  
7.15 ~~on individuals~~.

7.16 Sec. 12. Minnesota Statutes 2010, section 13.05, is amended by adding a subdivision  
7.17 to read:

7.18 Subd. 7a. Access to summary data. The responsible authority shall prepare and  
7.19 implement procedures to ensure that access to summary data is provided pursuant to  
7.20 section 13.05, subdivision 7. Preparation of summary data may be requested by any  
7.21 person. The request must be in writing in a form provided by the responsible authority.  
7.22 Within 30 days of the receipt of a request, the responsible authority must inform the  
7.23 requester of the estimated costs, if any, and provide:  
7.24 (1) the summary data requested;  
7.25 (2) a written statement to the requester, describing a time schedule for preparing the  
7.26 requested summary data, including reasons for any time delays;  
7.27 (3) access to the requester to the not public data for the purpose of the requestor's  
7.28 preparation of summary data; or  
7.29 (4) a written statement to the requester stating reasons why the responsible authority  
7.30 has determined that the requester's access would compromise the not public data.

7.31 Sec. 13. Minnesota Statutes 2010, section 13.05, is amended by adding a subdivision  
7.32 to read:

8.1 Subd. 7b. **Summary data nondisclosure agreement.** A nondisclosure agreement,  
 8.2 as required by section 13.05, subdivision 7, must contain at least the following:

8.3 (1) a general description of the not public data which is being used to prepare  
 8.4 summary data;

8.5 (2) the purpose for which the summary data is being prepared; and

8.6 (3) a statement that the preparer may be subject to the civil or criminal penalty  
 8.7 provisions of section 13.08 or 13.09 in the event that the not public data are disclosed.

8.8 Sec. 14. Minnesota Statutes 2010, section 13.05, is amended by adding a subdivision  
 8.9 to read:

8.10 Subd. 7c. **Paying for preparation of summary data.** Any costs incurred in the  
 8.11 preparation of summary data shall be borne by the requesting person. In assessing the  
 8.12 costs associated with the preparation of summary data, the responsible authority shall:

8.13 (1) provide to the requesting person an estimate of the costs associated with the  
 8.14 preparation of the summary data;

8.15 (2) collect any funds necessary to reimburse the entity for its costs before preparing  
 8.16 or supplying the summary data;

8.17 (3) charge no more than reasonable copying costs when the summary data being  
 8.18 requested requires only copying and no other preparation; and

8.19 (4) take into account the reasonable value to the entity of the summary data prepared  
 8.20 and where appropriate reduce the costs assessed to the requesting person.

8.21 Sec. 15. Minnesota Statutes 2010, section 13.09, is amended to read:

8.22 **13.09 PENALTIES.**

8.23 Any ~~person~~ individual who willfully violates the provisions of this chapter or any  
 8.24 rules adopted under this chapter is guilty of a misdemeanor. Willful violation of this  
 8.25 chapter by any public employee constitutes just cause for suspension without pay or  
 8.26 dismissal of the public employee.

8.27 Sec. 16. Minnesota Statutes 2010, section 13.32, subdivision 6, is amended to read:

8.28 **Subd. 6. Admissions forms; remedial instruction.** (a) Minnesota postsecondary  
 8.29 education institutions, for purposes of reporting and research, may collect on the  
 8.30 1986-1987 admissions form, and disseminate to any public educational agency or  
 8.31 institution the following data on individuals: student sex, ethnic background, age, and  
 8.32 disabilities. The data shall not be required of any individual and shall not be used for  
 8.33 purposes of determining the ~~person's~~ individual's admission to an institution.



9.1 (b) A school district that receives information under subdivision 3, paragraph (h)  
9.2 from a postsecondary institution about an identifiable student shall maintain the data  
9.3 as educational data and use that data to conduct studies to improve instruction. Public  
9.4 postsecondary systems annually shall provide summary data to the Department of  
9.5 Education indicating the extent and content of the remedial instruction received in each  
9.6 system during the prior academic year by, and the results of assessment testing and the  
9.7 academic performance of, students who graduated from a Minnesota school district within  
9.8 two years before receiving the remedial instruction. The department shall evaluate the  
9.9 data and annually report its findings to the education committees of the legislature.

9.12 Subdivision 1. **Definitions.** As used in this section, the following terms have the  
9.13 meanings given them.

9.14 (a) "Security information" means government data the disclosure of which the  
9.15 responsible authority determines would be likely to substantially jeopardize the security of  
9.16 information, possessions, individuals or property against theft, tampering, improper use,  
9.17 attempted escape, illegal disclosure, trespass, or physical injury. "Security information"  
9.18 includes crime prevention block maps and lists of volunteers who participate in community  
9.19 crime prevention programs and their home addresses and telephone numbers.

9.20 (b) "Trade secret information" means government data, including a formula, pattern,  
9.21 compilation, program, device, method, technique or process (1) that was supplied by the  
9.22 affected individual or organization, (2) that is the subject of efforts by the individual or  
9.23 organization that are reasonable under the circumstances to maintain its secrecy, and (3)  
9.24 that derives independent economic value, actual or potential, from not being generally  
9.25 known to, and not being readily ascertainable by proper means by, other persons who can  
9.26 obtain economic value from its disclosure or use.

9.27 (c) "Labor relations information" means management positions on economic and  
9.28 noneconomic items that have not been presented during the collective bargaining process  
9.29 or interest arbitration, including information specifically collected or created to prepare  
9.30 the management position.

9.31 (d) "Parking space leasing data" means the following government data on an  
9.32 applicant for, or lessee of, a parking space: residence address, home telephone number,  
9.33 beginning and ending work hours, place of employment, work telephone number, and  
9.34 location of the parking space.

10.1 (e) When denying a data request made under section 13.03, a government entity,  
10.2 upon request must provide a short description explaining the necessity for why the  
10.3 government data are classified as security information.

10.4 Sec. 18. Minnesota Statutes 2010, section 13.3805, subdivision 1, is amended to read:

10.5 Subdivision 1. **Health data generally.** (a) **Definitions.** As used in this subdivision:

10.6 (1) "Commissioner" means the commissioner of health.

10.7 (2) "Health data" means data on individuals created, collected, received, or  
10.8 maintained by the Department of Health, political subdivisions, or statewide systems  
10.9 relating to the identification, description, prevention, and control of disease or as part of  
10.10 an epidemiologic investigation the commissioner designates as necessary to analyze,  
10.11 describe, or protect the public health.

10.12 (b) **Data on individuals.** (1) Health data are private data on individuals.

10.13 Notwithstanding section 13.05, subdivision 9, health data may not be disclosed except as  
10.14 provided in this subdivision and section 13.04.

10.15 (2) The commissioner or a local board of health as defined in section 145A.02,

10.21 case, to alert persons who may be threatened by illness as evidenced by epidemiologic  
10.22 data, to control or prevent the spread of serious disease, or to diminish an imminent threat  
10.23 to the public health.

10.24 (c) **Health summary data.** Summary data derived from data collected under section  
10.25 145.413 may be provided under section 13.05, subdivision 7.

10.26 Sec. 19. Minnesota Statutes 2010, section 13.3806, subdivision 1a, is amended to read:

10.27 Subd. 1a. **Death investigation data.** Data gathered by the commissioner of health  
10.28 to identify the body of ~~a person~~ an individual believed to have died due to a declared  
10.29 emergency as defined in section 12.03, subdivision 1e, the circumstances of death, and  
10.30 disposition of the body are classified in and may be released according to section 12.381,  
10.31 subdivision 2.

10.32 Sec. 20. Minnesota Statutes 2010, section 13.3806, subdivision 5, is amended to read:

11.1 Subd. 5. **School health records.** (a) **Student health data.** Data collected for the  
11.2 health record of a school child are governed by section 144.29.
