BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4

Section 1. Minnesota Statutes 2012, section 47.59, subdivision 2, is amended to read: 1.5 Subd. 2. Application. Extensions of credit or purchases of extensions of credit by 1.6 financial institutions under sections 47.20, 47.21, 47.201, 47.204, 47.58, 47.60, 48.153, 1.7 48.185, 48.195, 59A.01 to 59A.15, 334.01, 334.011, 334.012, 334.022, 334.06, and 1.8 334.061 to 334.19 may, but need not, be made according to those sections in lieu of 19 the authority set forth in this section to the extent those sections authorize the financial 1.10 institution to make extensions of credit or purchase extensions of credit under those 1.11 sections. If a financial institution elects to make an extension of credit or to purchase an 1.12 extension of credit under those other sections, the extension of credit or the purchase of an 1.13 extension of credit is subject to those sections and not this section, except this subdivision, 1.14 and except as expressly provided in those sections. A financial institution may also 1.15 charge an organization a rate of interest and any charges agreed to by the organization 1 16 and may calculate and collect finance and other charges in any manner agreed to by that 1.17 organization. Except for extensions of credit a financial institution elects to make under 1.18 section 334.01, 334.011, 334.012, 334.022, 334.06, or 334.061 to 334.19, chapter 334 1.19 does not apply to extensions of credit made according to this section or the sections listed 1.20 in this subdivision. This subdivision does not authorize a financial institution to extend 1.21 credit or purchase an extension of credit under any of the sections listed in this subdivision 1.22 if the financial institution is not authorized to do so under those sections. A "consumer short-term loan" does not include any transaction 2.15 made under chapter 325J or a loan made by a consumer short-term lender where, in the 2.16 event of default on the loan, the sole recourse for recovery of the amount owed, other than 2.17 a lawsuit for damages for the debt, is to proceed against physical goods pledged by the 2.18 borrower as collateral for the loan. 2.19
- 2.20 (e) (f) "Consumer short-term lender" means an individual or entity engaged in the
 2.21 business of making, offering, or arranging consumer short-term loans, other than a state or
 2.22 federally chartered bank, savings bank, or credit union.
- 2.23 (g) "Debt-to-income ratio" means the ratio of the borrower's total monthly debt
