1.1 A bill for an act  
1.2 relating to capital investment; authorizing spending to acquire and better public  
1.3 land and buildings and for other improvements of a capital nature with certain  
1.4 conditions; modifying prior appropriations; establishing new programs and  
1.5 modifying existing programs; authorizing the sale and issuance of state bonds;  
1.6 appropriating money; amending Minnesota Statutes 2018, sections 16A.641, by  
1.7 adding a subdivision; 134.45, subdivision 5; 240A.09; 363A.36, subdivisions 1,  
1.8 4; 363A.44, subdivision 1; 462A.37, subdivision 5, by adding a subdivision; Laws  
1.9 2015, First Special Session chapter 5, article 1, section 10, subdivision 7, as  
1.10 amended; Laws 2017, First Special Session chapter 8, article 1, section 18,  
1.11 subdivision 3; Laws 2018, chapter 214, article 1, sections 2, subdivision 6; 7,  
1.12 subdivision 1; 21, subdivision 1; proposing coding for new law in Minnesota  
1.13 Statutes, chapters 116J; 174.

1.14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.15 **ARTICLE 1**

1.16 **APPROPRIATIONS**

1.17 Section 1. **CAPITAL IMPROVEMENT APPROPRIATIONS.**

1.18 The sums shown in the column under "Appropriations" are appropriated from the bond  
1.19 proceeds fund, or another named fund, to the state agencies or officials indicated, to be  
1.20 spent for public purposes. Appropriations of bond proceeds must be spent as authorized by  
1.21 the Minnesota Constitution, article XI, section 5, paragraph (a), to acquire and better public  
1.22 land and buildings and other public improvements of a capital nature, or as authorized by  
1.23 the Minnesota Constitution, article XI, section 5, paragraphs (b) to (j), or article XIV. Unless  
1.24 otherwise specified, money appropriated in this act:

1.25 (1) may be used to pay state agency staff costs that are attributed directly to the capital  
1.26 program or project in accordance with accounting policies adopted by the commissioner of  
1.27 management and budget;

2.1 (2) is available until the project is completed or abandoned subject to Minnesota Statutes,  
2.2 section 16A.642;

2.3 (3) for activities under Minnesota Statutes, sections 16B.307, 84.946, and 135A.046,  
2.4 should not be used for projects that can be financed within a reasonable time frame under  
2.5 Minnesota Statutes, section 16B.322 or 16C.144; and

2.6 (4) is available for a grant to a political subdivision after the commissioner of management  
2.7 and budget determines that an amount sufficient to complete the project as described in this  
2.8 act has been committed to the project, as required by Minnesota Statutes, section 16A.502.

2.12 To the Board of Regents of the University of

2.15 **Subd. 2. Higher Education Asset Preservation**  
2.16 **and Replacement (HEAPR)** **117,700,000**

2.17 To be spent in accordance with Minnesota  
2.18 Statutes, section 135A.046.

2.19 **Subd. 3. Institute of Child Development Building** **28,000,000**

2.20 To predesign, design, renovate, expand,  
2.21 furnish, and equip the Institute of Child  
2.22 Development building on the Twin Cities  
2.23 campus. This project includes the demolition  
2.24 and replacement of the 1968 building addition.

2.25 **Subd. 4. AB Anderson Hall Renovation** **4,300,000**

3.4 Upon substantial completion of a project  
3.5 authorized in this section and after written  
3.6 notice to the commissioner of management  
3.7 and budget, the Board of Regents must use  
3.8 any money remaining in the appropriation for  
3.9 that project for HEAPR under Minnesota  
3.10 Statutes, section 135A.046. The Board of  
3.11 Regents must report by February 1 of each  
3.12 even-numbered year to the chairs of the house  
3.13 of representatives and senate committees with  
3.14 jurisdiction over capital investment and higher  
3.15 education finance, and to the chairs of the  
3.16 house of representatives Ways and Means  
3.17 Committee and the senate Finance Committee,  
3.18 on how the remaining money has been  
3.19 allocated or spent.

5.23 **Subd. 2. Natural Resources Asset Preservation**

5.24 (a) For the renovation of state-owned facilities  
5.25 and recreational assets operated by the  
5.26 commissioner of natural resources to be spent  
5.27 in accordance with Minnesota Statutes, section  
5.28 84.946. Notwithstanding Minnesota Statutes,  
5.29 section 84.946, the commissioner may use this  
5.30 appropriation to replace buildings if,  
5.31 considering the embedded energy in the  
5.32 building, that is the most energy-efficient and  
5.33 carbon-reducing method of renovation.

8.4 project on the commissioner's list.

8.5 (j) To the extent that the cost of a municipal  
8.6 project exceeds two percent of the median  
8.7 household income in the municipality  
8.8 multiplied by the number of households in the  
8.9 municipality, this appropriation is also for the  
8.10 local share of the project.

8.11 (k) Local project match may include all costs  
8.12 associated with project planning, engineering,  
8.13 acquisition, and construction. The project  
8.14 grants are based on a reimbursable payment  
8.15 process and final reconciliation of the project's  
8.16 shared costs are determined by the  
8.17 commissioner of natural resources upon  
8.18 project completion certification.

8.19 (l) In unique instances where the local project  
8.20 sponsor has expended project money for  
8.21 engineering, acquisition, or construction prior  
8.22 to finalization of a grant agreement under this  
8.23 section, those local expenditures are  
8.24 reimbursable consistent with the match  
8.25 requirements of this section.

8.26 **Subd. 5. Canisteo and Arcturus to Hill Annex**  
8.27 **Open-pit Mine Groups**

8.28 From the general fund to expand monitoring  
8.29 and modeling of water levels in the Canisteo  
8.30 and Arcturus to Hill Annex open-pit mine  
8.31 groups, with priority on the latter. The  
8.32 monitoring and modeling results must be used  
8.33 by the commissioner to develop plans to  
8.34 control and reduce the water levels in each pit  
8.35 group and ameliorate, mitigate, or eliminate

9.1 the public safety hazards and groundwater  
9.2 contamination concerns resulting from rising

9.19 Regional Airport Authority, or both, to design  
9.20 the replacement of the ramps and staging areas  
9.21 that support the department's fire fighting  
9.22 response operations at the regional airports in

13.6 Subd. 2. **Local Government Roads Wetland**  
13.7 **Replacement Program** 10,000,000

13.8 To acquire land or permanent easements and  
13.9 to restore, create, enhance, and preserve  
13.10 wetlands to replace those wetlands drained or  
13.11 filled as a result of the repair, reconstruction,  
13.12 replacement, or rehabilitation of existing  
13.13 public roads as required by Minnesota  
13.14 Statutes, section 103G.222, subdivision 1,  
13.15 paragraphs (l) and (m). The board may vary  
13.16 the priority order of Minnesota Statutes,
