.6	Subdivision 1. Appropriation. \$3,300,000 is appropriated from the bond proceeds
.7	fund to the Board of Trustees of the Minnesota State Colleges and Universities for Bemidji
.8	State University to abate and demolish Maple Hall and Sanford Hall, and to complete
.9	design for the renovation of Decker Hall, Hobson Hall, and Memorial Hall into multiuse
.10	classrooms and study spaces, including replacing the HVAC system and constructing an
