1.6	Section 1. LAC QUI PARLE RESERVOIR IMPROVEMENTS.
1.7	Subdivision 1. Appropriation. \$2,200,000 is appropriated from the bond proceeds fund
1.8	to the commissioner of natural resources to predesign, design, and construct a parking lot
1.9	and an Americans with Disabilities Act (ADA) compliant walkway at the location commonly
1.10	known as Twin Bridges, approximately three miles southwest of the city of Appleton, at
1.11	Lac Qui Parle reservoir for safe access to popular fishing locations on the reservoir.
1.12	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
1.13	proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.14	the state in an amount up to \$2,200,000 in the manner, upon the terms, and with the effect
