1.6	Section 1. Minnesota Statutes 2013 Supplement, section 216C.412, subdivision 2,
1.7	is amended to read:
1.8	Subd. 2. Payments from public utilities. (a) Beginning January 1, 2014, and
1.9	each January 1 thereafter, through 2023, for a total of ten years, each electric public
1.10	utility subject to section 216B.241 must annually pay to the commissioner of commerce
1.11	five percent of the minimum amount it is required to spend on energy conservation
1.12	improvements under section 216B.241, subdivision 1a. Payments under this subdivision
1.13	must be included in the calculation of whether a utility's other spending on generation
1.14	exceeds the limits authorized for spending on generation under section 216B.2411,
1.15	subdivision 1, for investments proposed for commissioner of commerce approval after
1.16	July 1, 2013. The limits on spending in section 216B.2411 do not limit or apply to
1.17	payments required by this subdivision. Payments made under this paragraph count toward
