1.6	Section 1. [85.391] DEFINITIONS.
1.7	Subdivision 1. Scope. For purposes of sections 85.391 to 85.397, the following
1.8	terms have the meanings given them.
1.9	Subd. 2. Commissioner. "Commissioner" means the commissioner of natural
1.10	resources.
1.11	Subd. 3. State-supported trail grant-in-aid program. "State-supported trail
1.12	grant-in-aid program" means a program administered by the commissioner as described
1.13	in section 85.395.
1.14	Subd. 4. Race. "Race" means a timed event organized for a large number of
1.15	participants at one time over a course prepared specifically for the organized event.
