1.7	Subdivision 1. Appropriation. \$2,000,000 is appropriated from the bond proceeds fund
1.8	to the Board of Trustees of the Minnesota State Colleges and Universities for reconstructing
1.9	the driver training track at the Dakota County Technical College.
1.10	Subd. 2. Debt service. (a) Except as provided in paragraph (b), the board shall pay the
1.11	debt service on one-third of the principal amount of state bonds sold to finance projects
1.12	authorized by this section. After each sale of general obligation bonds, the commissioner
1.13	of management and budget shall notify the board of the amounts assessed for each year for
1.14	the life of the bonds.
1.15	(b) The board need not pay debt service on bonds sold to finance higher education asset
1.16	preservation and replacement (HEAPR). Where a nonstate match is required, the debt service
