1.6	Section 1. [3.8865] LEGISLATIVE ENVIRONMENTAL JUSTICE COMMISSION.
1.7	Subdivision 1. Establishment. A Legislative Environmental Justice Commission is
1.8	established.
1.9	Subd. 2. Environmental justice principle. The state of Minnesota acknowledges the
1.10	historical and disproportionately high or adverse effects of environmental pollution on
1.11	certain communities based on race, color, national origin, geography, and economic status.
1.12	The Legislative Environmental Justice Commission must strive for the fair treatment and
1.13	meaningful involvement of all people regardless of race, color, national origin, or economic
1.14	status with respect to developing, implementing, and enforcing environmental laws,
1.15	regulations, and policies.
1.16	Subd. 3. Membership. (a) The Legislative Environmental Justice Commission consists
1.17	of 12 members appointed as follows:
